Dear FOCUS Supporters:

2015 was another year of growth for DC's public charter school movement and for FOCUS. After a nation-wide search, FOCUS welcomed Irene Holtzman as its second-ever Executive Director. The board and I are thrilled with the energy and passion Irene brings to the job and look forward to continuing to support her and the FOCUS staff in the crucial work they do advocating for and supporting DC's public charter schools.

In the 2015-2016 school year, over 39,000 students attended a public charter school in the District, comprising nearly 45 percent of all public school students. However, even with the successes of the public charter school movement, as evidenced both by the long waitlists and the academic results of the charter schools, many challenges remain. I am proud to continue supporting FOCUS in its advocacy work to ensure DC's public charter schools have the autonomy, facilities, and funding they need to continue providing a high quality education to their students. I know that the schools also rely on the range of support FOCUS offers schools at every stage of development, from founding groups looking for more information about starting a charter school to high-performing schools thinking about how to serve more students.

I am also proud that for the second year in a row the National Alliance of Public Charter Schools ranked Washington, DC as the healthiest charter school movement in the nation. This accomplishment wouldn't be possible without the efforts of FOCUS, a range of charter school stakeholders and supporters, and, of course, the charter school leaders, staff, and board members.

We deeply appreciate your continued support and your engagement in the work that this organization does, and will continue to do, for the growing number of charter schools in Washington, DC.

Executive Director's Report

Dear Friends:

For the District of Columbia's public charter school movement, 2015 was a year that brought together our past, present, and future. Our past efforts and successes ensured another year of growth and progress in public school choice. We are now entering our 20th year of public charter schools in the District, and see a bright future for our charter school movement. The promise of quality and choice made two decades ago to District families stands strong, while steady progress continues to address barriers to equity and capacity.

In 2015 FOCUS continued to play a key role in collaborating with and educating decision-makers on an intricate web of legislation and oversight. Working with our partners and supporters, FOCUS helped drive outcomes that will best serve the District's charter school movement both now and in the future. Much has been done to consolidate support for charter schools, but a great deal remains to be achieved in improving the environment for the charter school movement in Washington, DC.

Our internal emphasis this year was on building the essential services and partnerships necessary to amplify our efficacy and impact.

We welcomed three new schools to the charter school sector, strengthened our advocacy platform, emphasized targeted communications and media relations, and built capacity in serving our schools, leaders, and stakeholders. We also completed a strategic plan, which will guide our work for the next three years (see page 20).

Our commitment remains to improve the quality and foster the growth of the District of Columbia's public charter schools.

We are deeply appreciative of your support in this effort as we look to the future.

Advocacy

FOCUS continued its role as the chief advocate for all 62 DC public charter schools in 2015. FOCUS's expertise in analysis and policymaking enabled collaborative work across the political spectrum that educated key elected officials about Washington, DC's public charter school sector.

Some key measures in 2015 that demonstrate the strength of our advocacy work include:

- FOCUS had a significant media presence in newspapers and news stations across the city, including the Washington Post. Over 20 editorials and op-ed pieces, supporting charter school platforms on funding, facilities, and autonomy, helped to shape public opinion and enhance debate on key issues in the charter school community.
- A lawsuit, initiated by FOCUS, led the District's Deputy Mayor of Education to review the process for how Local Education
 Agencies (LEAs) are funded in the city. A number of changes that will positively affect DC's charter schools will be enacted for
 the 2016-2017 school year (though substantial inequities remain and the lawsuit continues).
- No less than eight pieces of legislation were altered to be more hospitable to charter schools or buried due to FOCUS's efforts with the Council of the Whole and the Council Education Committee.
- FOCUS continued to facilitate positive relationships between Councilmembers and the charter school sector, in part by organizing a private breakfast for charter school leaders to discuss critical concerns and issues with Education Committee Chairman Grosso, as well as a meet and greet with new Councilmembers.
- By organizing testimonies before Council committees, building coalitions to carry the voice of stakeholders, and providing public comment during hearings, FOCUS' advocacy ensured that the charter school community was represented and engaged.











- provided three charter schools with Data Analyst Fellows to develop and improve data processes.
- Placed 17 data interns in charter schools to support school-defined data projects.
- Provided data consulting to 11 individual charter schools, supporting strategy, systems, and assessment data.
- Hosted the 6th annual DC Data Summit, attended by hundreds of DC teachers and administrators representing over half of all DC LEAS.
- Organized monthly data workshops and bootcamps featuring data leaders from the charter community sharing best practices, which were attended by 34 LEAs.

Data

The sector data housed at FOCUS has been used by the PCSB and countless public charter school leaders, shown in testimony before the DC Council, delivered to the Office of the Mayor, and requested by a multitude of public and private institutions dedicated to school reform.


Students enrolled in a charter




Students enrolled in DCPS

Membership dues from the Real Estate Council members in 2015 helped support a half-day facilities summit, where school leaders, operations staff, and board members came together to learn more about facilities projects, as well as an online facilities resource center. The online resource center includes a facilities vendor directory as well as a database of facilities-related RFPs and contracts that charter school staff can access to help inform their own facilities projects.



DC's Charter School Movement



Strategic Plan 2016 - 2018

In 2015 FOCUS underwent a strategic planning process to map out the next three years of our work. We engaged Brighter Strategies to facilitate the process and engage our myriad stakeholders through in depth interviews, focus group discussions, an online survey, and facilitated working sessions. The result of this process was a new vision and mission statement, a renewed emphasis on our current advocacy and school quality work, and the following five strategic goals for 2016 - 2018.

Advocacy

Serve as an advocacy convener for charter schools, collaborating with other organizations to ensure a consistent voice and develop a proactive advocacy agenda. Continue to serve as the primary advocate for DC's charter school sector, providing timely information and guidance to the schools and representing the sector with elected officials and government agencies.

Communications

Develop a strong external communications strategy that engages others and highlights successful, innovative practices of charter schools in Washington, DC. Continue working with reporters and the media to ensure an accurate representation of the positive effect of DC's charter school sector and to highlight the ongoing challenges charter schools face.

Charter Support

Consolidate and curate resources for DC public charter schools through a new online resource center and school leaders portal. Continue to provide a variety of school services to support schools from startup to opening, as they continuously improve, and through possible replication or expansion.

Unity

Facilitate the unity of the DC charter school community by providing opportunities for meaningful collaboration between charter schools. Continue to develop and strengthen relationships with other charter support organizations and connect them with the charter schools.

Sustainability

Ensure the long-term sustainability of FOCUS by engaging in purposeful organizational development. Continue to strengthen internal operations and actively seek diverse funding sources.
